**ENDORSEMENT**

A Case Management Conference (CMC) was held by teleconference on January 12, 2015, at 1:00 P.M., Eastern Time (Ottawa).

[1] A Notice pursuant to Section 22 of the *Specific Claims Tribunal Act* shall be sent to the Province of British Columbia.

[2] The Claimant shall provide the Respondent with an initial draft of the Common Book of Documents and the first draft of the Agreed Statement of Facts on or before **January 16, 2015**.

[3] The Respondent shall provide the Claimant with its draft preliminary List of Documents on or before **January 30, 2015** being understood that the Respondent may require additional time to complete the Common Book of Documents in the event that the Tribunal allows the amendments. In such a case, the Tribunal shall review with the Parties the timeframe for the production of the additional documents.

[4] The Parties shall provide the Tribunal with a draft Bifurcation Order on or before **January 23, 2015**. The question of historical compensation for the breach regarding the evaluation of the customs lands and the water right-of-way claims will be addressed at the liability phase as agreed to by the Parties.

[5] The Parties shall notify the Tribunal by letter on or before **January 30, 2015** whether or not there is an agreement regarding the description of the breach admitted by the Crown with respect to the water right-of-way claim.

[6] The Parties shall notify the Tribunal by letter on or before **January 30, 2015** whether or not they will retain the services of experts and shall provide information regarding the timeframe needed for the production of expert reports, if need be.

[7] The Respondent, should it wish to amend its pleadings, shall provide a draft Amended Response to the Claimant and the Tribunal on or before **February 16, 2015**.

[8] The next CMC will be held by teleconference on **February 23, 2015** at 1:00 P.M., Eastern Time (Ottawa).
