## ORDER

### Honourable Harry Slade

[1] The Claim of the Waywayseecappo First Nation was filed on July 4, 2012.

[2] On June 18, 2013, the Gamblers First Nation made application for leave to bring an application and application to be granted party status in the Waywayseecappo First Nation claim.

[3] On June 28, 2013, the Waywayseecappo First Nation filed a response to the application of the Gamblers First Nation.

[4] The Claim of the Gamblers First Nation was filed on September 16, 2013.

[5] At a Case Management Conference on September 16, 2013, at which Waywayseecappo First Nation, Gamblers First Nation and the Crown were represented, the possibility of dealing with the separate claims at the same time was contemplated, as reflected in the Endorsement dated September 20, 2013.

[6] Upon being advised by Counsel that each of the Parties consents to have the proceedings heard together and to determination of the claims at the same time in a single or concurrent decisions of the Tribunal,

### **THE TRIBUNAL ORDERS that:**

[7] The proceedings in File No. SCT-4001-12 and the proceedings in File No. SCT-4001-13 shall be heard together, subject to any further or other orders of the presiding member of the Specific Claims Tribunal at the hearing of the claims.

[8] These Claims of Waywayseecappo First Nation and Gamblers First Nation shall be determined at the same time in a single or concurrent decisions of the Tribunal.
