**ENDORSEMENT**

**Honourable Johanne Mainville**

A Case Management Conference (CMC) was held by teleconference on February 27, 2015, at 12:50 P.M., Eastern Time (Ottawa).

[1] The Parties shall continue to discuss the issue of bifurcation and shall report at the next CMC.

[2] The Claimant shall provide a written request for research documents relating to the disputed individuals in relation to the treaty annuity payroll on or before **March 3, 2015**. The Respondent shall provide its position with respect to this matter, on or before **March 10, 2015**.

[3] The Respondent shall reply to the Claimant's comments on oral history protocol on or before **March 13, 2015**.

[4] With respect to written discovery, the Claimant shall provide written questions to the Respondent on or before **July 31, 2015**, and the Respondent shall provide its written questions to the Claimant on or before **September 30, 2015**. If a written discovery is found necessary, the Claimant shall advise the Tribunal.

[5] A filing date for the Respondent's expert report(s) shall be set once the Parties advise the Tribunal whether or not the deadline for the filing of the Claimant's expert report(s) remains due on or before **November 16, 2015**. The Respondent shall have at least two months to respond to the Claimant's expert report(s).

[6] It is noted that the Claimant received a request from Chief Henderson and his Council to propose having the hearing held in the Sagkeeng community. The Tribunal and the Respondent do not object to this possibility.

[7] The Parties shall provide a revised proposed plan of proceeding by the next CMC.

[8] The next CMC will be held by teleconference on **May 1, 2015**, at 1:00 P.M., Eastern Time (Ottawa), followed by a CMC to be held on **June 18, 2015**, by teleconference at 1:00 P.M., Eastern Time (Ottawa).
