A Case Management Conference (CMC) was held by teleconference on January 20, 2015, at 2:00 P.M., Eastern Time (Ottawa).

[1] The Respondent will inquire whether there are any further documents and whether or not it intends to do any further documentary investigations and shall report on the status to the Claimant on or before **February 20, 2015**.

[2] The Claimant shall provide the Respondent with a draft Amended Declaration of Claim on or before **February 20, 2015**.

[3] The Respondent shall advise the Claimant prior to **February 20, 2015** whether its request for particulars is satisfied as provided by the Claimant or if it seeks further particulars. If the Respondent requires further particulars, the Claimant shall be prepared to make its position known in relation to the same at the CMC scheduled for the week following.

[4] On or before **February 20, 2015** the Claimant shall prepare for inclusion in the draft Agreed Statement of Facts such facts relating to the 1939 surrender.

[5] The Respondent will prepare a draft protocol with regards to Elder Testimony and provide it to the Claimant on or before **February 20, 2015**.

[6] The Claimant shall report on its intentions with respect to oral history evidence and expert reports on or before **February 20, 2015**.

[7] The completion of the Common Book of Documents, Agreed Statement of Facts and the Agreed Statement of Issues shall remain due on or before **April 30, 2015**.

[8] The next CMC will be held by teleconference on **February 23, 2015** at 2:30 P.M., Eastern Time (Ottawa). To the extent the matters scheduled for completion on or before February 20, 2015 may be reported on jointly, the Parties shall file a joint Case Management Brief. If a joint CMC Brief cannot be produced, the Parties shall provide individual CMC Briefs on or before the commencement of the next CMC.
