A Case Management Conference (CMC) was held by teleconference on April 14, 2014, at 11:00 A.M., Eastern Time (Ottawa).

[1] The Claimant may file a further Report by Bryan Schwartz, in Response to the Audrey Stewart Affidavit, limited to five (5) pages, to be served and filed on or before April 28, 2014.

[2] The Respondent may, not later than May 25, 2014, file and serve submissions containing its objections to the admissibility of the above Bryan Schwartz Report. The Respondent may make arguments available to it, including, but not limited to, concerns relating to procedural fairness and relevance. The Claimant shall file response submissions not later than June 25, 2014. The Parties may agree to vary these dates. If either party wishes to make oral submissions, a CMC will be scheduled for that purpose.

[3] Arguments concerning the admissibility of the Audrey Stewart Affidavit will be heard during the course of the hearing on the merits. Parties shall make written submissions respecting such admissibility in their respective Memoranda of Fact and Law, to be served and filed in a manner consistent with their agreed upon timetable for filing and service, as set out in their joint letter, dated April 8, 2014. The Claimant will file its submission, followed by the Respondent's.

[4] The Intervenor, Première Nation des Atikamekw d'Opitciwan, may file a Memorandum of Fact and Law after the Claimant and Respondent's Memoranda of Fact and Law are filed. Subject to any agreement among the Parties and the Intervenor concerning the filing date, the same shall be served and filed on or before August 8, 2014.

[5] The Parties may file responsive submissions to those filed by the above Intervenor on or before September 8, 2014.

[6] The hearing of this claim on its merits shall be scheduled for the duration of five (5) days, commencing September 15, 2014.
