ENDORSEMENT

Honourable Harry Slade, Chairperson

[1] Further to the letter filed with the Tribunal on November 27, 2015, the Parties agree to the below timetable for the compensation phase of proceedings:

- a) The Respondent shall serve and file a Memorandum of Fact and Law in Response to the Claimant’s Amended Memorandum of Fact and Law regarding Compensation dated October 2, 2015 on or before **February 15, 2016**.

- b) The Respondent shall serve its two Expert Reports on the Claimant on or before **February 19, 2016**.
- c) The Respondent shall serve and file its Memorandum of Fact and Law regarding realistic contingencies on or before **February 29, 2016**.
- d) The Claimant shall advise the Respondent and Tribunal regarding the status of its election to submit Responding Reports and whether there is need to examine the Respondent's experts on or before **February 29, 2016**. *(If the Claimant elects to file expert reports at this time, the Parties shall revise this plan of proceeding accordingly).*
- e) The examinations/cross-examinations of the Respondent's Experts, if necessary, shall take place from **February 29, 2016 to March 1, 2016**.
- f) The Claimant shall serve and file a Reply to the Respondent's Response on or before **March 7, 2016**.
- g) The Claimant shall serve and file its Response to the Respondent's Memorandum on realistic contingencies (dated February 29, 2016, under (c) above) on or before **March 14, 2016**.
- h) The Respondent shall serve and file its Reply, if any, to the Claimant's Response on realistic contingencies on or before **March 21, 2016**.
- i) A Pre-Hearing Conference will be held on **April 4, 2016**.
- j) The hearing on compensation will take place in Saskatoon from **April 11-13, 2016**.

[2] Further:

- a) The Parties shall provide the Tribunal with a written report on their progress on or before **February 24, 2016**;

- b) The Claimant shall advise whether it intends to examine the Respondent's expert(s) on or before **February 24, 2016**;
- c) The Claimant shall also advise of its intentions with respect to filing a Responsive Expert Report; and,
- d) Either Party may request a Case Management Conference at any time.
