UPON THE REASONS FOR DECISION of this Tribunal dated December 23, 2016 awarding compensation to the Claimant;

AND UPON THE REQUEST ON CONSENT of the Parties set out in their letter and draft order filed with the Tribunal on February 8, 2017 (attached to this order);

THE TRIBUNAL ORDERS THAT:

[1] The Respondent shall pay to the Claimant compensation in the sum of \$4,500,000.00.

[2] The Respondent shall also pay to the Claimant interest calculated at the Band Trust Fund Rate from April 1, 2016 to December 23, 2016 in the sum of \$60,282.19 for a total sum of \$4,560,282.19.

[3] The Respondent shall also pay to the Claimant interest owed according to subsection 36(2) of the *Specific Claims Tribunal Act* on \$4,560,282.19, to and including February 15, 2017, in the amount of \$20,240.16.

[4] The total amount payable by the Respondent to the Claimant is \$4,580,522.35.

[5] Payment of \$4,580,522.35 shall be made by trust cheque to the Claimant's legal counsel in one installment on or around February 15, 2017, and this shall be full and final satisfaction of compensation owing according to the December 23, 2016 Reasons for Decision and the *Specific Claims Tribunal Act*.

UPON THE DECISION of this Tribunal dated December 23, 2016 awarding compensation to the Claimant;


THIS TRIBUNAL ORDERS THAT:

5. Payment of \$4,580,522.35 shall be made by trust cheque to the Claimant's legal counsel and this shall be full and final satisfaction of compensation owing according to the December 23, 2016 Decision and the *Specific Claims Tribunal Act*.
