ENDORSEMENT

A Case Management Conference was held in Tofino, British Columbia on October 19, 2017, at 9:30 A.M., Pacific Time.

[1] The Parties reported that a draft Agreed Statement of Facts and a Common Book of Documents had been prepared. These documents are likely complete, subject to facts or documents that may arise from the expert evidence hearing that was about to take place. It was

expected that these documents would be filed at the end of the expert evidence hearing, or shortly after.

[2] The Parties reported that they have exchanged a draft Agreed Statement of Issues and are working collaboratively to resolve differences.

[3] Upon consent, it is directed that Written Submissions shall be served and filed as follows, subject to review at the request of a Party if the expert evidence hearing transcript is not completed in a timely fashion as indicated below:

- (a) delivery of the expert evidence hearing transcript on or before **December 19, 2017**;
- (b) Claimant's Written Submissions on or before **January 10, 2018**;
- (c) Respondent's Written Submissions on or before **February 26, 2018**; and,
- (d) Claimant's Reply Submissions on or before **March 26, 2018**.

[4] The Parties are requested to file on or before **April 13, 2018** a Joint Book of Authorities for the validity hearing commencing **April 17, 2018** in Tofino, British Columbia.

[5] It is directed that section 19 (pages 98 and 99) and Tabs 51 and 52 be removed from the filed Expert Report of the Respondent's proposed expert, Steven J. Minnie, and that references to them be struck from the list of contents and list of supporting documents.

[6] The Parties are requested to file a Joint Status Report on the progress of preparation of the expert evidence hearing transcript on or before **December 1, 2017**.

[7] A Pre-Hearing Conference will be held by teleconference on **March 29, 2018**, at 12:00 P.M., Eastern Time (Ottawa).
